Thence South 61 Degrees 05 Minutes 31 Seconds East for a distance of 1215.48 feet with a common line to the John Andrew & Susan Ladd property described in Deed Book 331 Page 269 [passing through a rebar and cap (set) at 1192.48 feet on the creek bank] to a point in the centerline of a creek;

Thence with the centerline meanders of the creek and common lines to the Ladd property the following (13) Thirteen courses:

- 1. South 22 Degrees 50 Minutes 36 Seconds West for a distance of 32.92 feet to a point;
- 2. South 87 Degrees 02 Minutes 31 Seconds West for a distance of 79.76 feet to a point;
- 3. South 26 Degrees 28 Minutes 42 Seconds West for a distance of 107.73 feet to a point;
- 4. South 76 Degrees 05 Minutes 24 Seconds West for a distance of 50.93 feet to a point, said point being located South 33 Degrees 23 Minutes 02 Seconds East for a distance of 13.13 feet from a rebar and cap (set):
